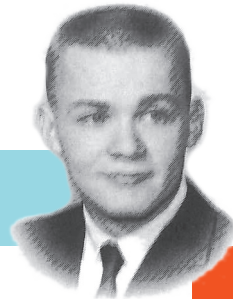
- Fred Habegger Sr purchased distribution rights to Bryant Heating & Cooling in Cincinnati and sets up shop in Northside

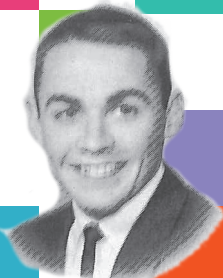

- Winton Road facility opens



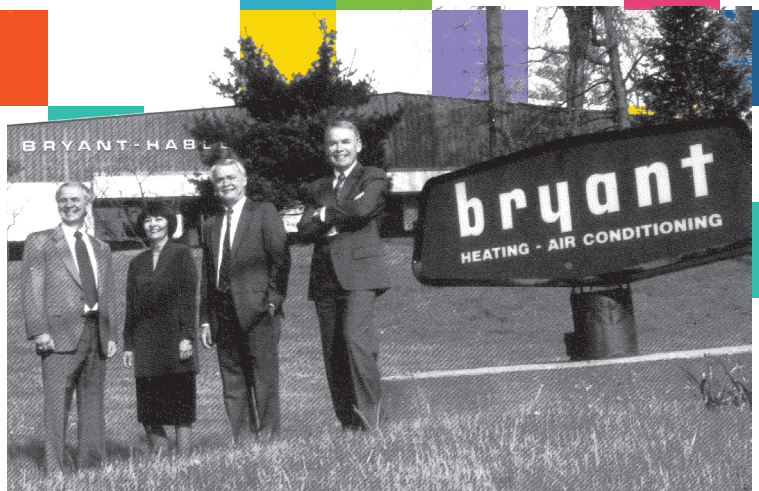
